



The Times at Barco, They Are a'Changin'

Thirty years ago, when the Barco Law Library at Pitt last searched for a library director, one of the major issues for the search committee was finding a director who could coordinate a local area network (LAN). The network would enable faculty to print documents in their secretaries' offices (gasp) and law school administrators to establish internal email lists (double gasp). Adding to the significance and excitement of that search was anticipation about Pittsburgh's plan for hosting the AALL Annual Meeting the following summer.

Now, as we search for a new library director, after several years of interim directors interrupted only for a short time by Marc Silverman's brief internal ascent to permanent director before retiring, the Barco Law Library is a much different place. In our current ad for a library director, the requirements and qualifications are general – designed to attract a dynamic variety of candidates. The line in the ad the most entertains me is this one: "We also seek candidates with knowledge of and experience with emerging information technology." Is there any law librarian on the planet who hasn't known about and experienced emerging information technology? Clearly, the search committee is not out to intimidate the candidate pool.

These days, there's no point in emphasizing a single current project, like the old LAN, in the job ad. Legal education, ABA standards, technology, and budgets are changing too quickly and in too many ways for a law school to expect that one realm of competence proves anything about a candidate's ability to actually run the library. The library director has to be a wizard who can spin straw into a sufficient quantity of gold that we can subscribe to specialized databases for our moot teams (including the one that competes in French) and otherwise maintain a collection that will inspire and support ever-evolving faculty and student research interests. This wizard also needs to conjure up fascinating research lessons to convince increasingly skeptical students that they really cannot and should not even try to find everything via Google. The spell books authored by this wizard have to be filled with the magic words that will soothe anxieties about machine generated evil incursions into innocent information quests. Those machine-generated incursions are a tribe of constantly shape shifting monsters. The wizard/library director should also know the spells for enticing researchers to talk with the librarians about their projects and to realize the value of having assistance from librarians.

The search committee didn't put these details, even without the mystical elements, into the job ad. Believe me though, there is a lot of exciting work happening at Pitt Law and there's plenty of room for a new library director to make a mark. If any of you are looking for a career change, a nice team of co-workers, and a good benefits package, feel free to call any of the Barconians (i.e. people who work at the Barco Law Library).¹

There will be a celebration in Washington, DC sometime over the summer (TBA) where the award will be presented at a ceremony.

A Selection of Recent Reads²

- When Women Were Dragons by Kelly Barnhill 5/5
 - Britiny's thoughts: One of the very few books that I read where I simultaneously felt
 multiple feelings at once. This book will make you irate for the truth to be told. In a
 memoir style, this book features the main character, Alex, as she grows up (U.S.
 1950s-1960s) in a world where the existence of dragons is consistently denied, despite
 any and all signs that say otherwise. Other characters will pull on your heartstrings.
 Truly worth the read.
- Vaster Wilds by Lauren Groff 5/5
 - O Dan's thoughts: I picked up Vaster Wilds just as the Men or Bear meme was trending on social media last week. Imagine my surprise to read "For even a good man was more deadly than the worst of the bears" early on in the novel, giving this historical fiction a contemporary connection. The narrator, a young servant girl, has lived a life of toil punctuated with episodes of violence that culminates with the famine at the Jamestown colony. It is then that she decides to make her escape, taking her chances in the wilds. What ensues is a breathless journey of survival where hunger, hardship, and isolation are the price of freedom. A brilliant story. Well written and well worth the read.
- None of This is True by Lisa Jewell 4.5/5
 - Anonymous' thoughts: This was a book club pick for March of 2024 but it still sticks in my brain. The formatting is unique in a modern style that's very appealing. I'd recommend the audiobook over the physical copy. None of This is True threads the relationship between two women who happen to be 'birthday twins' one woman, Alix, who's a successful podcaster and an unassuming woman, Josie, who's always been "a little strange." As quickly as Josie is introduced into Alix's life she disappears and leaves a tragedy in her wake. This story is full of twists that will rip your heart out by the end.
- We Begin at the End by Chris Whitaker 4/5
 - Megan's thoughts: We Begin at the End is a novel about two types of families "the ones we are born into and the ones we create." A truly suspenseful thriller about what happens when vengeance comes to town decades later and what one family will do to protect their own.
